## Standards Version Advancement Process (SVAP)

Under the ONC's Standards Version Advancement Process (SVAP), developers of certified health IT are permitted to voluntarily certify to newer versions of adopted standards that have been approved by the National Coordinator via the SVAP. iPatientCare intends to voluntarily certified to the below standard by 31st Dec 2023.
